**DEPARTMENT OF TRANSPORT AND PUBLIC WORKS: WESTERN CAPE
NATIONAL LAND TRANSPORT ACT, 2009 (ACT 5 OF 2009)
EXTRAORDINARY MEASURES IN DECLARED AREAS: BELLVILLE AND PAARL**

1. I, Daylin Gary Mitchell, Provincial Minister of Transport and Public Works in the Western Cape—
 - (a) declare, under section 91(1) of the National Land Transport Act, 2009 (Act 5 of 2009) (the Act), Bellville and Paarl as areas in respect of which the notification prescribing the extraordinary measures contemplated in section 91(2) of the Act may be made (the declared areas), as set out in paragraph (b)(i), (ii) and (iii); and
 - (b) give notice that—
 - (i) under section 91(2)(a) of the Act, the route and ranks, and a part of the Bellville Public Transport Interchange, set out in the Schedule, that are situated in the declared areas are closed for the operation of any minibus taxi-type service for a period of three months (the closure period), commencing on 26 February 2022;
 - (ii) under section 91(2)(b) of the Act, any operating licence or permit authorising any minibus taxi-type service on the closed route contemplated in subparagraph (i) is suspended in respect of that route for the duration of the closure period;
 - (iii) under section 91(2)(c) of the Act, and subject to subparagraph (v), no person may, for the duration of the closure period, undertake any minibus taxi-type service on the closed route contemplated in subparagraph (i), or in terms of an operating licence or permit suspended as contemplated in subparagraph (ii);
 - (iv) under section 91(5) of the Act, a current minibus taxi operator who contravenes this Notice, or fails to comply therewith, commits an offence and is liable on conviction to a fine of R5000, or to imprisonment for a period not exceeding six months; and
 - (v) under section 91(6) of the Act, a temporary permit may be issued to an operator of a motor vehicle, minibus or midibus to operate a minibus taxi-type service, or to an operator of a bus to operate a bus service, on a closed route or at a closed rank during the closure period in substitution for the prohibited services contemplated in subparagraph (i).

2. This Notice comes into operation on 26 February 2022.

1. Ek, Daylin Gary Mitchell, Provinciale Minister van Vervoer en Openbare Werke in die Wes-Kaap—
 - (a) verklaar, kragtens artikel 91(1) van die “National Land Transport Act, 2009” (Wet 5 van 2009) (die Wet), Bellville en die Paarl as gebiede ten opsigte waarvan die kennisgewing gemaak kan word wat die buitengewone maatreëls beoog in artikel 91(2) van die Wet voorskryf (die verklaarde gebiede), soos uiteengesit in paragraaf (b)(i), (ii) en (iii); en
 - (b) gee kennis dat—
 - (i) kragtens artikel 91(2)(a) van die Wet, die roete en staanplekke, en 'n gedeelte van die Bellville Openbare Vervoerwisselaar, uiteengesit in die Bylae, wat in die verklaarde gebiede geleë is, gesluit is vir die bedryf van enige minibustaxi-tipe diens vir 'n tydperk van drie maande (die sluitingstydperk), met ingang van 26 Februarie 2022;
 - (ii) kragtens artikel 91(2)(b) van die Wet, enige operateurslisensie of permit wat enige minibustaxi-tipe diens op die geslote roete beoog in subparagraaf (i) magtig, opgeskort is ten opsigte van daardie roete vir die duur van die sluitingstydperk;
 - (iii) kragtens artikel 91(2)(c) van die Wet, en behoudens subparagraaf (v), geen persoon, vir die duur van die sluitingstydperk, enige minibustaxi-tipe diens op die geslote roete beoog in subparagraaf (i), of ingevolge 'n operateurslisensie of permit wat opgeskort is soos beoog in subparagraaf (ii), mag bedryf nie;
 - (iv) kragtens artikel 91(5) van die Wet, 'n huidige minibustaxi-operateur wat hierdie Kennisgewing oortree, of versuim om daaraan te voldoen, 'n misdryf pleeg en by skuldigbevinding strafbaar is met 'n boete van R5000, of met gevangenisstraf vir 'n tydperk van hoogstens ses maande; en
 - (v) kragtens artikel 91(6) van die Wet, 'n tydelike permit uitgereik kan word aan 'n operateur van 'n motorvoertuig, minibus of midibus om 'n minibustaxi-tipe diens te bedryf, of aan 'n operateur van 'n bus om 'n busdiens te bedryf, op 'n geslote roete of by 'n geslote staanplek gedurende die sluitingstydperk ter vervanging van die verbode dienste beoog in subparagraaf (i).
