Under section 6(3)(a) of the Remuneration of Public Office Bearers Act, 1998 (Act 20 of 1998), I determine that the salaries and allowances of the Provincial Ministers and Members of the Provincial Parliament of the Western Cape are the same as the upper limits of the relevant salaries and allowances determined by the President by Proclamation 39/2018, as published in *Government Gazette* 42107 dated 13 December 2018, with effect from 1 April 2018.
