## MINISTER REAGEN ALLEN HITS THE STREETS PATROLLING WITH NHW'S **ACROSS THE WESTERN CAPE**

This feature aims to address questions you may have about the running and operations of your neighbourhood watch.

#### Are there any insurance policies for NHW structures?

Unfortunately, not, the nature of NHWs is such that it becomes financially unsustainable. Since NHW members are volunteers, they come and go all the time and therefor it would be very challenging financially. We must also remember that NHW volunteers are only "eyes and ears" and should never put themselves at risk to be harmed.

#### What is the difference between accredited and non-accredited NHW structures?

Accredited NHW structures are regulated in terms of Section 6 of the Western Cape Community Safety Act of 2013. By being accredited they are eligible to receive free training, resourcing, and funding from the Department of Community Safety (DoCS). The department has a memorandum of Understanding (MOU) with the City of Cape Town to only support accredited NHW structures. Therefore, by virtue of their accreditation, NHWs in the Metropole also qualify to be part of the City of Cape Town's projects that they roll out. Accredited structures are also more trustworthy as all their patrollers are screened by SAPS. Non-accredited structures are not recognized by the department and City of Cape Town.

# Can't the Department populate a letter to banks to make it easier for banks to allow them to open

No, this is not possible as each bank has their own process to open an account. Presently we have system of which we provide an "Entity BAS" form for banks to confirm structures have an account with a particular bank. This system has been in existence for some time and most banks are aware of government requirements. It is the prerogative of the structure to follow the processes of each bank to open an organisational account.

#### Can you patrol without being accredited; do you have the same rights as an accredited structure?

Accreditation with the Department is voluntarily, and it does not mean you can't operate as a NHW. If you report the existence of your NHW and your intention to patrol to SAPS you can patrol. However, should you decide to become accredited with the department, there are many benefits for your NHW.

#### Can the R10 000 funding be used to pay for hospital bills if a member of the NHW gets injured on duty?

The funding of R10 000 provided to NHW structures is solely for administration cost, operational cost and only cost that will enhance the functionality of the NHW. The funding cannot be used for personal usage or to pay any person who does something for the NHW. We encourage NHWs to make use of government clinics and hospitals.

New Horizon Neighbourhood Watch in collaboration with the Grassy Park Youth Desk Crime Prevention Unit hosted the Child Protection Matters programme in the New Horizon Pelican Park community, offering the Fingerprint Drive to community members. The programme took place on Saturday 28th May 2022 at the New Horizon Neighbourhood Watch Feeding Soup Kitchen.

The aim of the programme was to shed light on missing person's and to share information about children that had gone missing, and sadly not found. The aim was to advocate for children's rights. The importance of having your child's fingerprints taken is to be prepared if any situation arises, this form can be provided to your nearest SAPS station to assist at a faster pace.

Importantly, community children have grown to fear the police. We wanted our children to see that the police are not to be feared upon. In this instance, we introduced the SAPS 10111 hand signal for young children. They were taught to always remember it for emergency reasons.

The distribution process entailed the children treated to a warm hearty cooked meal and receiving party pack treats with school essentials, such as shirts and shirts.

We are thankful for the turn up by parents bringing their children to be fingerprinted irrespective of the weather. It shows community spirit and that community members are taking back their streets by working together with safety agencies.

### **NEW HORIZON'S HOSTS** MANDELA DAY MASS CLEAN UP

New Horizon NHW hosted a Mass Community Clean Up Operation for their 67 minutes for Mandela Day, on 18th July 2022 at 13h30pm. In attendance, was Alderman JP Smith Mayco Member for Safety and Security and Grassy Park SAPS Captain, Wynita Kleinsmith and Sergeant Adams.

The aim for the project was to get everyone involved in keeping their community and surrounding environment clean. Neighbourhood watches, organizations, and residents of New Horizon Pelican Park were invited to donate 67 minutes of their time for the initiative. For us to be proudly South African and initiate the transferring of values that our former president Nelson Mandela instilled is to firstly take pride in ourselves and in this instance protecting our environment. New Horizon Pelican Park have constant issues of illegal dumping on open fields taking place in early hours of the morning and evening.

On the 21 March 2022, New Horizon Neighbourhood Watch launched their illegal dumping pamphleteering campaign to promote educational awareness on the erosion of our environment caused by dumping. Operation clean ups are imperative and ongoing as it is closely related to the City of Cape Towns "broken window theory".

If you see something do something about it. Hence, why we are seeing our fields are being dumped with not only household refuge but rubble and old furniture too. It takes us as residents of the community to log illegal dumping complaints ourselves and often have to take it a step further by participating in cleanup operations. The City of Cape Town has made things so much easier by having the" My Cape Town App", which allows you to log any service request or emergency. You also get the C3 system which is available by means of using your cellphone. We need to empower ourselves to tackle these issues.

Illegal dumping and dirt associates closely with criminal activity. Where an open field containing dumping is, you find copper being burnt there; you find makeshift structures built from the materials dumped there. From one by-law broken it evolves into more criminal activity.

Our awareness is simple, stop dumping, take pride in your community and be proud of where you come from. We thank our Ward Councillor Gerry Gordon for assisting with the

black bags and arranging for the dirt collected bags to be picked up.
