AMENDED DECLARATION OF PLACES WHERE THE CARRYING ON OF THE BUSINESS OF STREET VENDOR, PEDLAR OR HAWKER IS PROHIBITED/RESTRICTED: MITCHELL'S PLAIN TOWN CENTRE CAPE TOWN MUNICIPAL AREA

Notice is hereby given in terms of Section 6A(2)(h) of the Businesses Act 71 of 1991 that the notice published in the Provincial Government Gazette No 5408 dated 24 December 1999 is hereby replaced by the following notice: that the area shown by the figure A, B, C and D within Spine Road, Merrydale Road, A Z Berman and Wespoort Roads within the Mitchell's Plain Town Centre, Cape Town Municipal area, as shown on Map A accompanying this notice, is an area in which the carrying on of the business of street vendor, pedlar or hawker is prohibited, with the exception of the indicated informal trading sites numbered 1 to 1107 on the Maps marked 1 to 13 on the plans accompanying this notice.

The area constituted by the trading sites reflected on the plans is hereby declared an area in which the carrying on of the business of street vendor, pedlar or hawker is restricted to persons in possession of a valid permit or lease, and that the trading sites mentioned above be let out by means of a permit/lease, and that no street vending, peddling or hawking be permitted in the informal trading sites if a person is not in possession of a valid permit/lease for that particular trading site.

This notice shall take effect on the date of publication in the Official Gazette.

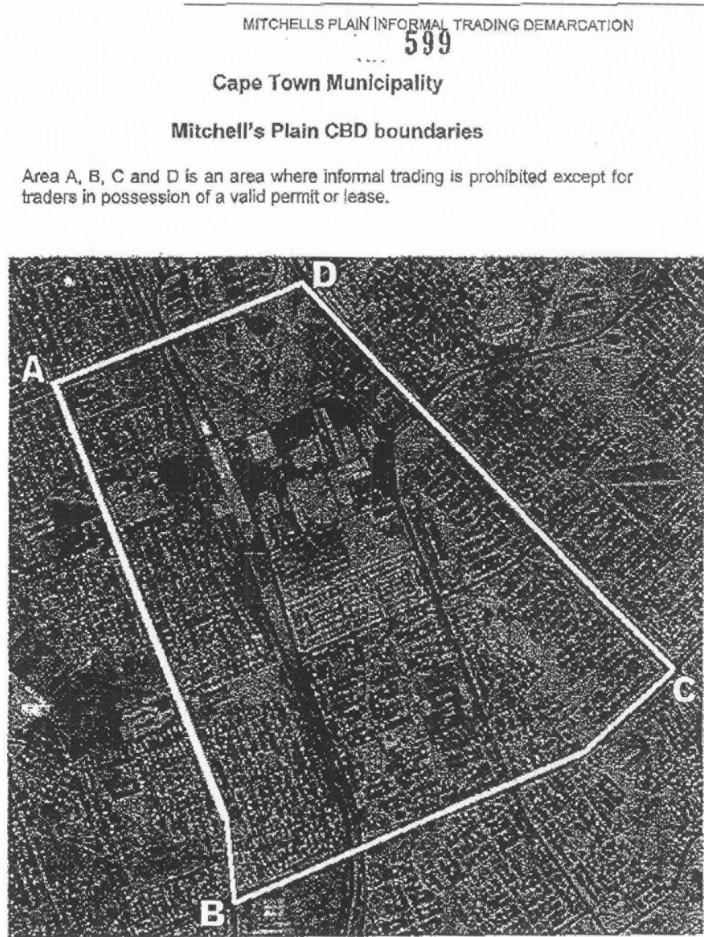

Hierdie kennisgewing tree op die datum van publikasie in die amptelike Staatskoerant in werking.

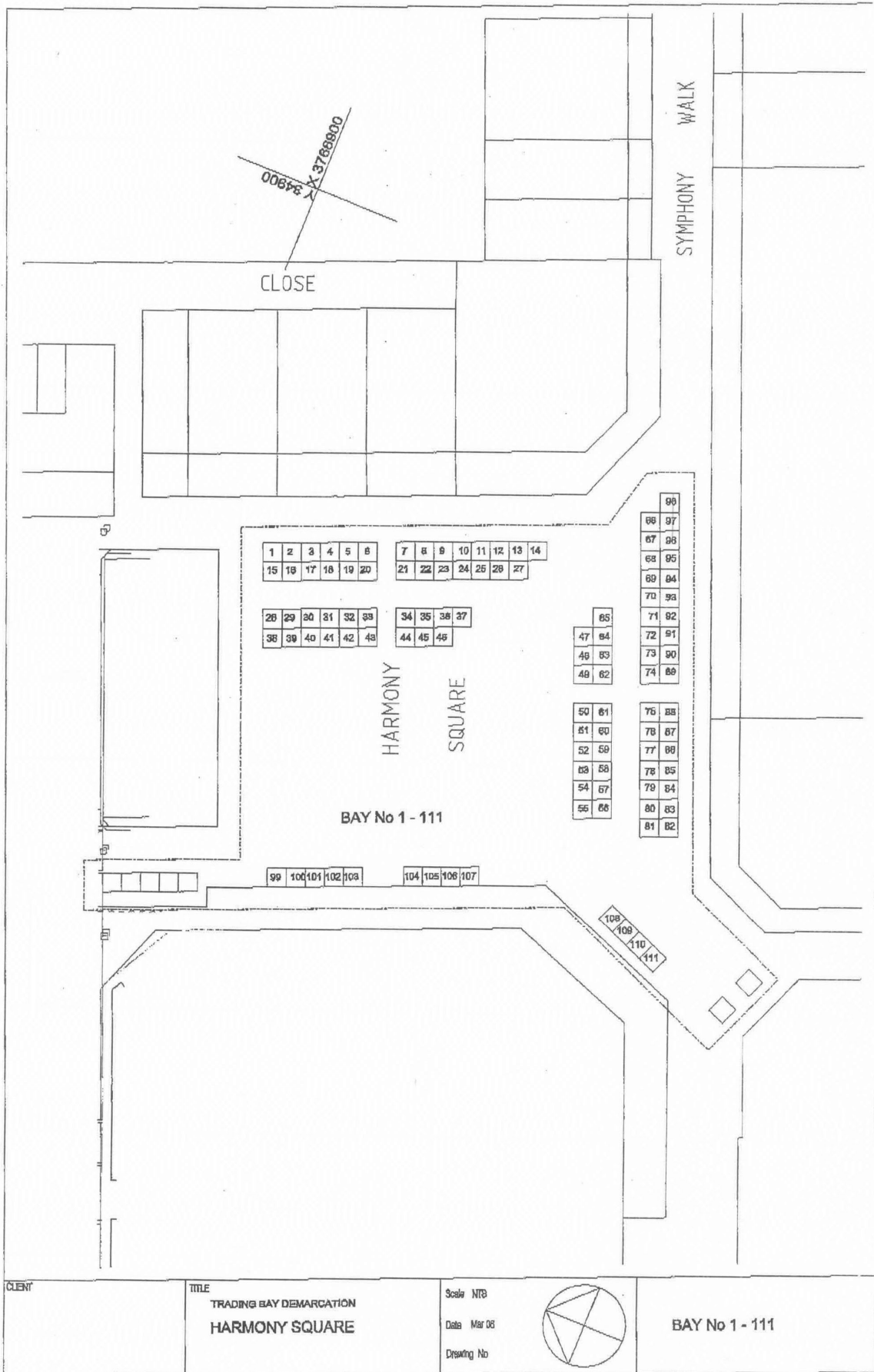

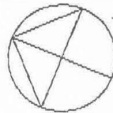
Map A
