MEC for Transport and Public Works, Robin Carlisle, was in for a surprise earlier today when he visited the Boston Circle AVTS Roadworthy Station to mark the beginning of the Free Safety Check Campaign, a joint initiative of the Retail Motor Industry Organisation (RMI) and Safely Home.

This festive season initiative offers Western Cape motorists the opportunity to get their vehicles tested for roadworthiness absolutely free - before they load up their families to take them on holiday or to visit loved ones over the festive season. Carlisle, not one to pass up a bargain, opted to have his Ministerial vehicle, a 2009 Mercedes Benz ML350 tested, and to his great surprise, it failed. The vehicle was found to have a faulty headlight and the pressure on one rear wheel exerted by the hand-brake was found to be inadequate.

Minister Carlisle addressed all motorists planning to travel this festive season, saying "I am very impressed by the test. If my ministerial vehicle, which is a 2009 model, and professionally maintained to a high level, can develop hidden safety risks without me realising, then any vehicle can too. I urge all motorists to take advantage of the offer of free roadworthy testing before loading up loved ones. I am insisting that my family bring in their vehicles as soon as possible, especially the youngsters, and will be bringing in the Landy, my personal vehicle. You have absolutely nothing to lose if you do, and absolutely everything to lose if you don't."

Carlisle congratulated AVTS Group MD Ferose Oaten and her team of inspectors on her exceptional facilities and the willingness of AVTS to take part in this important initiative, together with Safely Home and RIM. He further promised to attend to the issues identified immediately and at time of going to press, the MEC's vehicle had been handed into the government garage for repair.
