 - (d) ukuqinisekisa ukuba kulandelwa izikhokelo zomgaqo-nkqubo ezifanelekileyo ekuqhutyweni kweli ziko leenkomfa. 20
 - (e) ukuqinisekisa ukuba iziko eli liyabhengezwa;
